This supplementary prospectus (the "**Supplementary Prospectus**", which definition shall include all information incorporated by reference herein) to the base prospectus dated 5 April 2023 (the "**Base Prospectus**", which definition includes the base prospectus and all information incorporated by reference therein) constitutes a supplementary prospectus for the purposes of Section 87G of the Financial Services and Markets Act 2000 and is prepared in connection with the £3,000,000,000 Euro Medium Term Note Programme (the "**Programme**") established by OSB GROUP PLC (the "**Issuer**").

Terms defined in the Base Prospectus have the same meaning when used in this Supplementary Prospectus.

This Supplementary Prospectus is supplemental to, updates, must be read in conjunction with, and forms part of, the Base Prospectus.

This Supplementary Prospectus has been approved by the United Kingdom Financial Conduct Authority, which is the competent authority for the purposes of Regulation (EU) 2017/1129 as it forms part of domestic law by virtue of the European Union (Withdrawal) Act 2018, as amended (the "**UK Prospectus Regulation**") and relevant implementing measures in the United Kingdom, as a supplemental prospectus to the Base Prospectus. The Base Prospectus constitutes a base prospectus prepared in compliance with the UK Prospectus Regulation and relevant implementing measures in the United Kingdom for the purpose of giving information with regard to the issue of Notes under the Programme.

The Issuer accepts responsibility for the information contained in this Supplementary Prospectus. To the best of the knowledge of the Issuer, the information contained in this Supplementary Prospectus is in accordance with the facts and makes no omission likely to affect its import.

1. Purpose

The purpose of this Supplementary Prospectus is to:

- (B) disclose revised credit ratings assigned to the Issuer by Fitch Ratings Limited ("**Fitch**") and Moody's Investors Services Ltd ("**Moody's**"); and
- (C) provide updated 'no significant change' and 'no material adverse change' statements.

2. Incorporation by reference of the Issuer's 2023 Half Year Results

On 10 August 2023, the Issuer published its unaudited consolidated interim report for the six months ended 30 June 2023 (the "**2023 Half Year Results**").

3. Issuer credit ratings

On 16 May 2023, Fitch announced that the long-term issuer default rating of the Issuer was revised from BBB- to BBB. On 20 April 2023, Moody's announced that the long-term issuer rating of the Issuer was revised from Baa3 to Baa2.

4. Significant/Material Change

Save as disclosed on pages 21 to 24 (*Impact of the rapidly changing interest rate environment on customer behaviour and EIR accounting*) (inclusive) of the 2023 Half Year Results, there has been no material adverse change in the prospects of the Issuer since 31 December 2022. There has been no significant change in the financial performance or financial position of the Group since 30 June 2023, being the date of the Issuer's last published consolidated financial information (as set out in the 2023 Half Year Results).
